THOMAS EDWARD HUNT, JR., M.D.

Whereas, On December 24, 2017, 2011, MedChi, The Maryland State Medical Society, and its component, Baltimore City Medical Society, lost a member of nearly 60 years, Thomas Edward Hunt, Jr., M.D.; and

Whereas, Dr. Hunt was born in Pittsburg, Pennsylvania, and in 1944, during high school, enlisted in the United States Navy and completed boot camp in Bainbridge, Maryland; and

Whereas, He completed a tour of duty in the Pacific theater, following the surrender of Japan on August 15; he received an honorable discharge in 1946, and enrolled in the pre-med program at West Virginia University; and

Whereas, Dr. Hunt earned his medical degree at the University of Maryland School of Medicine and completed a residency in orthopedics at the Johns Hopkins Hospital; and

Whereas, He maintained a practice in Baltimore's historic Mt. Vernon, also seeing patients at ten hospitals, including Hopkins, Children's Hospital and Center, Mercy and Harbor Hospitals; he was chief of orthopedic surgery at Harbor from 1965 to 1973; and

Whereas, For over 40 decades, Dr. Hunt held clinics for children with cerebral palsy and neuromuscular disorders in Cumberland, Prince Frederick, Cheverly, the Great Oaks Center, and the Baer School, located in west Baltimore; and

Whereas, He retired in 2016, allowing more time for enjoying his extensive library of Baltimore and Maryland history; he was the unofficial historian of MedChi; and

Whereas, In his honor and recognition of his passion for both history and medicine, MedChi established the annual Hunt Lecture, to present speakers on a range of medical and historical topics; and

Whereas, Dr. Hunt lent his vast knowledge to many projects, including the restoration of the University of Maryland School of Medicine's Davidge Hall and MedChi's history of medicine committee; and

Whereas, He served as president of BCMS, the Maryland Orthopedic Association and the Medical Alumni Association of the University of Maryland; and

Whereas, Dr. Hunt's volunteer service was recognized with numerous awards: the BCMS Foundation Community Service Award, Health Care Hero Award of the Daily Record and the Spirit Award of The Christophers, the latter also presented to Mother Teresa and President Jimmy Carter; and

Whereas, Dr. Hunt survived his first wife, Mary Genevieve Maley, and his second wife Amy Glenn

Angell; and friend, Mary Catherine Cole; he is survived by his children: sons, James Hunt, Thomas Hunt; daughters, Mary Ann Kowzan Angela Hunt and Kathleen Pandolph; stepson, Robert Angell and stepdaughter, Robert Angell; nine grandchildren and five great grandchildren, and stepgrandfather of four and step great-grandfather of one; now therefore, be it

Resolved, That the members of Baltimore City Medical Society and MedChi House of Delegates have adopted this Resolution as an indication of the deep respect which the medical community holds for Dr. Hunt, and be it further
