2023 Advocacy Highlights

- **PROTECTED PHYSICIAN SERVICES, PAYMENTS, AND THE PRACTICE OF MEDICINE** Maintained funding of Medicaid E&M payments resulting in payments for the first time being higher than Medicare; established critical exceptions to burdensome and unnecessary step therapy requirements; blocked legislation that would have inappropriately and permanently expanded pharmacist scope of practice regarding vaccinations; and ensured protections from out-of-state investigation and penalties for Maryland physicians who provide legally-protected reproductive care.
- **PROTECTED AND EXPANDED PATIENT ACCESS TO CARE** Expanded coverage and eliminated cost-sharing requirements for breast and lung cancer screenings; ensured that Marylanders will continue to receive health care through telehealth and that physicians will be properly paid for providing telehealth services; protected reproductive freedom and health care services; expanded Medicaid benefits to cover gender-affirming care; and expanded Medicaid reimbursements to cover behavioral health services delivered in primary care settings through the Collaborative Care Model.
- **ADDRESSED BEHAVIORAL HEALTH TREATMENT AND RECOVERY NEEDS** Assisted in establishing the Behavioral Health Value-Based Purchasing Pilot Program, an intensive care coordination model using value-based purchasing in the specialty behavioral health system; established the Behavioral Health Workforce Investment Fund to educate, train, certify, recruit, place, and retain behavioral health professionals and paraprofessionals; and established a Commission on Public Health to make recommendations to improve the delivery of "foundational public health services" in the State of Maryland.

- **THE CENTER FOR THE EMPLOYED PHYSICIAN** provides resources and educational programming to assist physicians who are currently employed or are considering entering into an employment arrangement. 442 Maryland physicians responded to a survey, giving feedback about their concerns regarding practicing medicine in an employed setting and physicians considering employment most requested a resource that would aid in contract negotiations, while physicians who are currently practicing in employed settings most requested current compensation models. Both groups were also concerned about maintaining autonomy.
- **THE CENTER FOR VALUE-BASED CARE** lead the charge in protecting physician interests as Maryland healthcare shifts to value-based care; has worked to make sure the CareFirst value-based bill included physician and patient protections; and was a strong supporter of the Maryland Primary Care Program, the most successful value-based care program for MD adult primary care. MedChi is also a leader in developing specialty value based care programs in MD with the EQIP program.
- **THE CENTER FOR A HEALTHY MARYLAND** announces the appointment of Allan C. Browder, Jr. as our new Executive Director. Allan will be taking over for Debbie Sciabarrasi, who will be stepping aside from her Center duties, while continuing on the MedChi side. This year, the MD Physicians Health Program is celebrating its 45th Anniversary with a series of events, including lectures, fundraising activities, and a research symposium. As of 10/1, there are a total of 85 participants in the three programs. The MedChi Museum of MD Medical History debuted Phase II in conjunction with the 2023 Hunt History of MD Medicine Lecture. New features include the Video and Rare Books Room, a wall of Past Presidents in sequential order, additional displays, including the historic Napoleon Chest, portraits and more.
- **THE MEDCHI DEPARTMENT OF CONTINUING MEDICAL EDUCATION (CME)** conducted over 287 CME activities and added 3 new jointly provided programs with new partners, and 21 Accredited Providers of CME throughout the state of MD. The CME department continued to improve and enhance online options as the nation and the state continued to deal with the evolving COVID variants. Topics for these events focused on practicing medicine in the post COVID-19 environment, telemedicine, cybersecurity, Opioids, addictions, and other important clinical and non-clinical topics. MedChi has adopted the ACCME’s CME Passport to improve and streamline the administration and management of its activities and issuing CME certificates which allows them to be able to assist physician members and others in finding resources to support their continuing education needs, licensure, and permit requirements. The MedChi CME Department has also continued work with hospitals and other organizations in its accrediting system to assist them in finding and expanding alternative ways of providing education to physicians, working with providers in that system to maintain the accreditation process.
