What is MedChi?

- MedChi is the seventh oldest medical society formed in 1799 in Annapolis, MD
- The Mission of MedChi, The Maryland State Medical Society, is to serve as Maryland's foremost advocate and resource for physicians, their patients, and the public health of Maryland
- MedChi is the largest physician organization in Maryland
 - Physicians primary care and specialists
 - Medical residents and students
 - Practice managers and medical staff



Maryland Board of Physicians

- The Board of Physicians issues licenses for physicians in Maryland.
 - Main regulatory authority for physicians
 - Also handle disciplinary actions
- International applicants must meet educational requirements, pass a qualifying exam, and demonstrate oral and written competency in the English language to qualify for a medical license in Maryland.

How to Apply for Your Medical License

- Complete an online application with the Maryland Board of Physicians at <u>www.mbp.state.md.us</u> and include all of the following:
 - Form IML2 Verification of Education and English Language Instruction
 - Form IML3 Verification of Postgraduate Medical Education
 - Form IML7 State Board Licensure and Examination Certification
 - Nonrefundable fee of \$890 for graduates of international medical schools; \$790 for graduates of schools in US territories, Puerto Rico or Canada
 - Passport quality photo, as well as diplomas, certificates, and other documents as appropriate

Education Requirements (Must meet one of these)

- a. Doctor of Medicine Degree from a school of medicine accredited by the Liaison Committee on Medical Education (LCME);
- b. DO Degree from a school of osteopathy in the US territories or possessions, Puerto Rico, or Canada with standards equivalent to American Osteopathic Association
- c. Doctor of Medicine Degree from any medical school and obtain Education Commission for Foreign Medical Graduates (ECFMG) certification
- d. Complete a "Fifth Pathway Program" which applies to students who are US citizens who have completed medical school except for social service and post-graduate training requirements
- e. Fulltime teaching at an LCME-approved medical school (case-by-case basis)

Additional post-graduate training applies to b through e

Pass a Qualifying Exam

- a. United States Medical Licensing Examination (**USMLE**)
- b. Comprehensive Osteopathic Medical Licensing Exam (COMLEX)
- c. Licentiate of the Medical Council of Canada
- d. A State or DC Board of Medicine Exam
- e. National Board of Medical Examiners Exam
- f. Federal Licensing Exam(FLEX) and must meet minimum scores
- g. Special Purpose Exam (**SPEX**) or COMVEX exam required if
 - i. Last licensing exam was more than 15 years ago; and
 - ii. Applicant has not been licensed, board-certified or practiced medicine for 10 years.
 - iii. Exam may be waived if one of these conditions not met

English Language Requirements (Must document one of the following)

- a. Graduation from a "recognized" English-speaking high school, professional school or undergraduate school after three years of enrollment
- Passed United States Medical License Exam (USMLE) Step 2 Clinical Skills
- c. Achieved a score of 26 or more on the "Speaking Section" of the internet-based **TOEFL** (Test of English as a Foreign Language)
- Achieved at least an "advanced" score on the OPI (Oral Proficiency Interview)


More on the Credentialing Process

- Q: What credentialing services will the Board of Physicians accept for the evaluation of foreign degrees?
- A: Federation Credentialing Verification Service at https://www.fsmb.org/licensure/fcvs/overview
- Q: Do I need to take courses?
- A. This will depend on your education and practice history. You may be required to take two years of post-graduate training by an accredited organization.
- Q: How long will the credentialing process take?
- A: The Maryland Board of Physicians tries to meet a 4 month standard.
