Grants & Education Division

The Physicians Foundation extended our grant to improve tools and resources to integrate SDOH (Social Drivers of Health) screenings and resource navigation into medical practices.

Phase I of the project to survey physicians and review tools and resources is complete.

The Charles County Domestic Violence Division, with support from the Maryland Department of Health and Maternal and Child Health Bureau granted funding to the CADV to provide training and technical assistance to the Center for Abused Persons (CAP), which is the local Domestic Violence Service Provider in Charles County.

A Grant Proposal has been submitted to the **Maryland Historical Trust** to fund the development of architectural renderings and a detailed plan for the MedChi Museum of Maryland Medical History. This plan and the renderings will be used to build a detailed fundraising case for the museum and leverage donations.

The Center for a Healthy Maryland is preparing a proposal to the Health Resources and Services Administration (HRSA) for **Supporting the Mental Health Among the Health Professions Workforce**. The RFP is expected to be posted by May 1st.

Maryland Physician Health Program

As of 4/18/2024, there are a total of **75** participants in the three programs. We additionally have 3 evaluation only referrals from the Maryland Board of Physicians that we are working on. We have 4 intake appointments scheduled and 3 additional referrals/inquiries that we are following up on.

We are launching our collaboration with **Cabana** to provide an individualized wellness and strengths building experience. Check the website, **myCabana.Health**, and watch the video and the Voyage feature video. We have slots for 25 participants.

Our **Lemons to Lemonade** series will continue on May 9, 2024, with Dr. Cristina Feather who will speak on Where Do We Want to Go for Help?

The Physician Health staff will be presenting to the GBMC Medical Board on May 14, 2024.

The Center hosted a "Meet the Neighbors" event on March 12th and welcomed close to 60 people from local organizations and businesses to our space and showed them our museum.


