MARYLAND'S EPISODE QUALITY IMPROVEMENT PROGRAM, EQIP, IS NOW OPEN FOR ENROLLMENT

A value-based Medicare incentive payment opportunity for Maryland practitioners

BALTIMORE – July 16, 2024 – MedChi is pleased to announce that enrollment for the fourth performance year of the Episode Quality Improvement Program (EQIP) is now open. EQIP engages Maryland Medicare practitioners who care for Medicare beneficiaries in care transformation and value-based payment. Through the Episode Quality Improvement Program, physicians and other practitioners help the state meet its Medicare savings target under the Total Cost of Care (TCOC) model.

The Maryland Health Services Cost Review Commission (HSCRC) created EQIP for specialist practitioners in 2022. The program was developed in conjunction with MedChi, The Maryland State Medical Society, and CRISP, Maryland's state-designated HIE, with the input of physicians and other practitioners from across the state. EQIP is for all Maryland Practitioners, both general and specialists. This upcoming year, EQIP will be using the Patient Centered Episode System, or PACES, as the episode grouper. More information on PACES can be found on their website: The PACES Center. Episodes have been designed surrounding the following specialties: Allergy, Behavioral Health, Cardiology, Dermatology, Gastroenterology, Ophthalmology, Orthopedics, Pulmonary/Critical Care, Rheumatology, Urology, Emergency Department. However, there is no limitation to the type of specialist that wishes to enroll in one of the EQIP episodes.

Gene Ransom CEO of MedChi explained "EQIP is an amazing program for Maryland physicians, it allows access to an advanced payment bonus, while assisting the State of Maryland in meeting goals under the TCOC agreement. MedChi is ready and willing to help any practitioner who wishes to learn more or sign up for EQIP."
