


Q1: Do you recommend cannabis to patients?



Q3: How many patients are you managing who have been recommended medical cannabis with currently?




Q4: Of the above patients, how many patients have you referred for medical cannabis?







Q7: If you used Telehealth for the recommendation of medical cannabis, did you feel comfortable using Telehealth to do so?




Q8: Do you think Telehealth should be continued to be used for initial visits for a cannabis recommendation?
