Getting Started Step 2: Log-in to MDPCP Connect

MDPCP Connect is a peer-to-peer learning platform that will serve as the central hub for the MDPCP communications. Through Connect, practices and CTOs are able to communicate with other participants to share ideas and examples. The Learning Network will publish resources, such as guidance documents, webinars and group updates to Connect, and will maintain a program calendar. By now, many of you should have received instructions for logging on to MDPCP Connect. If you do not already have an account, you may self-register.

After obtaining access, users should complete the following steps to capitalize on available resources and functions of Connect:

1. Complete your profile
2. Locate and join any group of interest to view topic related information and updates
3. Set your Connect email notifications
4. Check out the MDPCP Calendar
5. Click the Libraries tab to view a list of FAQs and resources
6. Peruse the Chatter discussions and ask any questions you may have

Self-Registration Process

When self-registering, you will need your MDPCP Participant ID. For practices, your MDPCP ID is T#MD####. For CTOs, your ID is CTO0####.

1. Click on the [Connect Registration Link](#)
2. Enter your contact information in each field. For Affiliation, select "Model Participant". Enter your Model Identifier exactly as appears in MDPCP.
3. After you click the Submit Request button
4. Allow 3-5 business days for your request to be processed. Once CMS approves your access, you will receive an email from the CMMI Help Desk confirming your registration for the Community.
5. In 5-7 business days, you will receive a Welcome Email containing your username and a link to join the community. Click the link provided in the email to create your password. You must click Forgot Password to set up your password.
6. After clicking the link, you will navigate to the site's page to create your password.
7. You will receive another Welcome Email confirming that CMS has added you to the MDPCP All Community on Connect.

Getting Started Step 3: Register for MDPCP Portal

As a part of your participation in MDPCP, you are required to gain access to the MDPCP Portal web-based platform. Through the Portal, MDPCP practices and CTOs will access attribution and payment information, submit reporting requirements to CMS, and manage practitioner and staff rosters.
