#### MEDCHI URGES REPORTING AND SCREENING TO PREVENT CORONAVIRUS SPREAD

BALTIMORE, January 25, 2020 – The Public Health and Emergency Preparedness Committees of MedChi, The Maryland State Medical Society, are recommending immediate action and increased awareness to prevent, or at least slow, the spread of the coronavirus.

Richard Bruno, MD, MPH, Family & Preventive Medicine Physician, and Chair of MedChi's Public Health Committee, explained "We are seeing an accelerated spread of a novel coronavirus originating in Wuhan, China, and responsible for at least 42 known deaths since November 2019. As of Saturday January 25<sup>th</sup> there are two confirmed cases in the US (Seattle and Chicago), with more expected." He went on to explain "coronaviruses are a group of viruses that cause respiratory symptoms in animals and humans (about 5-10% of the common cold illness can be attributed to the coronavirus). However, the reproduction number (R0) of this new strain of the coronavirus may be higher than the 2002 SARS outbreak and the 1918 Spanish Flu pandemic, and it **can be spread person-to-person before symptoms emerge**."

Kathleen Hough, MD, Emergency Physician, and Chair of MedChi's Emergency Preparedness Subcommittee, expressed concern stating "there is reason to believe this may be an airborne virus which can spread similarly to measles. For now, **airborne and contact precations should be used with suspected carriers** who may have traveled from an endemic country (currently mainland China, Taiwan, and Thailand). This may also require quarantine of suspected carriers. There is no vaccine against coronavirus."

Symptoms of coronavirus are fever, cough, and shortness of breath. It seems to be affecting those with chronic illness more severely than previously healthy people, but there have been multiple deaths of treating healthcare professionals.

MedChi's Public Health Committee and Emergency Preparedness Subcommittee are recommending screening patients for travel from endemic countries within the prior 14 days and implementing airborne and contact precautions. Clinicians should immediately report patients who meet the above criteria to their local health department. This is an evolving situation and MedChi will continue to inform our members of any critical updates.

### COUNTY COMPONENT CONNECTION DURING COVID-19

Dr. Manahan delves into various decades-long events that negatively influenced the public's perception of the medical profession, thereby detracting from the Rockwellian images that we know.

• Thankfully, all is not lost. Dr. Manahan shares her belief that physicians can once again garner the respect they so richly deserve, while moving bravely into the twenty-first century with solid solution-driven ideas. The information in the presentation encourages all physicians to take up their brushes and paint a new "Rockwellian Portrait," as they embark upon medical roles that they now define.



### MEDCHI MANAGED TESTING SITE SCHEDULING



#### WORKING WITH THE STATE ON TESTING

- Governor Hogan expanded the availability of point of care testing.
- We worked with the State to have an ad-hoc committee that includes several MedChi members and BOT member Eric Wargotz, MD
- In mid-July, the State of Maryland began discussing ongoing testing shortages with Dr. Rajiv Shah, President of the Rockefeller Foundation on how a public/private partnership could work together to scale up productions of rapid Point of Care (POC) testing.
- Governor Hogan announced that Maryland is the first state in the compact to move forward and place an initial order for 250,000 tests and systems from BD.

### VACCINE

MedChi has a representative on the state vaccine committee and we recently sent draft vaccine plan to the membership for comment.

MedChi will be working with the Maryland Health Department to help educate on the vaccine plan, and make sure physcians have access to ImmuNet and CRISP.

#### WEEKLY DR. HAFT CALLS

As of October there have been over 56 separate webinars in this series with over 2,900 different participants

- Early on MedChi worked with Secretary Neall and Dr. Howard Haft for facilitating regular calls, providing vital updates on COVID-19
- MedChi participated in these calls to stay up to date on COVID-19 pandemic
- □ These calls also provided much needed CME to our members and other Maryland Physicians while many live meeting were cancelled.
- MedChi's CME Department has worked throughout the pandemic, with the Maryland Department of Health to provide CME Credit for all of the MDH COVID-19 Maryland Update webinars, presented by Dr. Howard Haft.

### MedChi Worked With Component Societies, To Help Physicians Apply For Various Programs

MedChi Successfully Helped Hundreds Of Physicians Implement Tele-health...





The Maryland Health Care Commission (MHCC) partnered with MedChi to provide education and grant assistance, for physicians to provide telemedicine to their patients.

#### MedChi The Marginal Same Marked Same

**CareFirst BlueCross BlueShield (CareFirst) and the Maryland State Medical Society (MedChi)** launched a grant program to provide independent physician practices with five or fewer members, a year of complimentary access to DrFirst's Backline Telehealth platform for physicians who enroll between March 1<sup>st</sup> and December 31<sup>st</sup> of 2020.

With the help of CareFirst and MHCC, MedChi has been able to help many Maryland Physicians receive much needed grants, to provide telehealth services to their patients.

### **TELEHEALTH GRANTS**

### MEDCHI IS WORKING ON OTHER TELE-HEALTH RESOURCES

- RPM MedChi is working with different platforms on Remote Patient Monitoring options, to provide even more economic opportunities for physicians
- E-Prescribe tool MedChi continues to work with DrFirst and iPrescribe
  - iPrescribe is an app with drug and controlled substance prescribing, medication history, PDMP queries, allergy alerts and more;
  - Provides real-time drug prices to physicians so they can let patients know out-of- pocket costs; and

#### MEDCHI DEVELOPED A TELEHEALTH CODING GUIDE



#### Telehealth Coding Guidelines

- Throughout this national public health emergency, Medicare will pay physicians for Telehealth services at the same rate as in-person visits for all diagnoses, not just services related to COVID-19.
- Physicians licensed in one state may provide services to Medicare beneficiaries in another state. State licensure laws still apply.
- Patients may receive telehealth services in all areas of the country and in all settings, including at their home.

#### Terminology:

- Telehealth/telemedicine: audio & video
- Virtual check-in: audio only
- E-Visit: patient portal, secure email, HIPAA compliant text messages

#### Medicare and Medicare Advantage

Updated 7.23.20 – The Public Health Emergency has been extended, so Telehealth will continue to be paid by Medicare for the foreseeable future.

Telehealth - where the location of in-person encounter would normally be furnished

- Office visit CPT: 99201-99205 & CPT: 99211-99215
- Place of Service: 11
- Modifier: 95
- New & Established patients
- Append the new modifier, CS, for evaluation of COVID-19 services. Medicare will pay at 100%.
- Allowed to bill CPT 99211 for COVID specimen collection instead of G2023.
- \*Please note, some Medicare Advantage plans, may still require POS 02, please check with each payer for most recent updates

Virtual Check-ins - CMS will reimburse CPT 99441-99443 at the same rate as 99212-99214

- CPT: 99442 (11-20 minutes)

#### MEDCHI WORKS ON SCOPE OF PRACTICE



We are working closely with specialty societies including anesthesiology, ophthalmology, and orthopedic groups to advocate that scope of practice encroachments are not initiated in ways that are unnecessary to addressing the public health crisis and potentially adverse for patient care.

#### TORT REFORM

MEDCHI WORKED CLOSELY WITH GOVERNOR HOGAN TO ISSUE EXECUTIVE ORDER

MARYLAND -PUBLIC SAFETY IMMUNITY ACT (MARYLAND CODE, § 14-3A-01(B) OF THE PUBLIC SAFETY ARTICLE

- This statute provides a health care provider with immunity from civil liability if that health care provider acts with "good faith" and under "a catastrophic health emergency proclamation." Maryland Governor Hogan issued such a proclamation pursuant to Maryland Code, § 14-3A-01(b) of the Public Safety Article on March 5, 2020. To fall under the immunity protection of this Act, certain conditions apply:
- If you are providing normal/routine care for a non-COVID-19 patient, then the immunity of this Act would not apply because that care has no relation to the "catastrophic health emergency proclamation" of Governor Hogan. Accordingly, if a patient had COVID-19, but was being treated for a non-COVID-19 condition, this immunity also may not apply.
- The immunity *would* apply if the health care provider was rendering care within the scope of the "Governor's orders[,]" and those acts are to "save lives during a public health emergency." The provider would need to strictly follow the Order of the Governor or any Department of Health ("DOH") criteria (or other State established criteria) to obtain the immunity
