MEDCHI ANNOUNCES LEGISLATION TO HELP PROTECT MARYLAND PATIENTS FROM HARMFUL HEALTH INSURANCE PRACTICES

HB 1015 to Address Dangerous “Step Therapy” Health Insurer Protocols That Jeopardize Patient Access to Care

BALTIMORE, March 1, 2013 — MedChi, The Maryland State Medical Society, today announced that it has sponsored legislation (HB 1015/SB 746) to help address a dangerous health insurer restriction known as “step therapy,” which jeopardizes the health of Marylanders and prevents Maryland patients from accessing timely and effective health care. “Step therapy” or “fail first” policies require patients to try and fail on up to five older, less effective treatments before the insurer will cover the treatment originally prescribed by a patient’s doctor. The delay can result in days, weeks, or months of unnecessary suffering for patients and increased health care costs.

“Step therapy hurts Maryland patients, unnecessarily prolongs ineffective treatment, and prevents patients from immediately starting the treatment their doctors think is best,” said MedChi President Brian Avin, MD. “Maryland insurers have inserted themselves into the physician-patient relationship and are making decisions about how to treat patients, all while making Maryland patients jump through unnecessary hoops. MedChi strongly opposes step therapy and other onerous insurer protocols which not only force patients to bear added physical and emotional burden, but also often force patients to take a predetermined list of medications that are detrimental to their health.”

The MedChi-sponsored legislation (HB 1015/SB746) calls for the following changes to the step therapy process:

- Limit the time period a patient can be subjected to step therapy to the period deemed necessary by a prescribing physician to determine the treatment’s clinical effectiveness, or a period no longer than 30 days.
- Give physicians the ability to override the step therapy protocol under specific circumstances when the physician believes it is in the best interest of the patient;
- Establish guidelines to ensure providers have an expeditious process to override step therapy under certain circumstances if the providers believe it is medically in the best interest of the patient; and

“Many states have recently begun to reevaluate health insurer step therapy protocols and their negative impact on patients, with many acting legislatively to help curb insurer abuses. MedChi is proud to join the ranks of those seeking to change the dangerous and costly step therapy process through legislative avenues,” added MedChi Executive Gene Ransom.

A May 2010 MedChi member survey found that, for 95% of Maryland physicians, health insurer protocols had a “somewhat” or “very negative” impact on the doctor’s ability to effectively treat patients, and 88.5% of physicians identified insurance barriers such as pre-approval, step therapy, drug switching and other protocols as “burdensome,” “very burdensome,” or as a “major hassle.” For more information about MedChi or about its efforts to help curb health insurer abuses, visit www.medchi.org.
